York Theater "98th Birthday Boo Ha-Ha"

Bob Baker Marionette Theater

LATOS was proud to collaborate with the Bob Baker Marionette Theater on September 18, 2021 to present the "98th Birthday Boo Ha-Ha," the first of what is promising to be a successful series of "Organ Nights" for the Bob Baker Marionette Theater. LATOS' own Mark Herman performed for the event and delivered several LATOS plugs to a sold-out house. LATOS Directors Dorsey Caldwell and Stirling Yearian set up LATOS banners and distributed brochures to event attendees. Most members of the LATOS Board of Directors were also present in the audience to experience the first cooperative event between LATOS and the Bob Baker Marionette Theater since the Pandemic of 2020-2021.

The evening was a celebration of the 98th anniversary of the opening night of the York Theater in Highland Park. Originally home to a Wurlitzer Style B, the York Theater now houses the Jack Darr organ, a custom Allen GW-4 digital theatre organ in a console built by Ken Crome of Reno, NV in the image of the Brooklyn Paramount Wurlitzer. As may have been the case on opening night, patrons were greeted by a half-hour organ show before the festivities began, and the organ show was met with enthusiastic applause. The evening continued with the singing of "Happy Birth-

day" to the York Theater and a vaudeville-style variety show featuring an exciting array of vintage and new marionettes, including the debut of the brand-new marionette duo of Dr. Frankenstein and his Monster who performed to the hilarious soundtrack of the famous "Putting On The Ritz" tap dance routine from the film.

Organ solos were intermingled with the marionette variety acts, and then the evening took a turn only Bob Baker Marionette Theater could produce as a troupe of marionettes emerged from the grand drape dancing to live organ music. The audience was thrilled by the perfect and natural pairing of theatre organ music and vintage marionettes, and they offered many cheers and rounds of applause throughout the routine.

The feature act of the evening was the screening of the 1921 Buster Keaton silent film, "The Haunted House" accompanied by Mark Herman at the organ. This one-reel comedy short was a stunt-filled laugh-riot, as is typical of Buster Keaton comedies, and the haunted house theme was a perfect kick-off to Bob Baker Marionette Theater's "Halloween Spooktacular, A Puppet Marvel" series which premiered September 18 and will run through October 31 with half-hour organ shows prior to most performances. LATOS Receives Substantial Donation from the Merle Trust

LATOS has become the beneficiary of a portion of the estate of long time theatre organ enthusiasts Raymond and Ramona Merle. The Merles were longtime real estate investors in the Newport Beach area. Over the past few months, LATOS has received two sizeable disbursements from the Raymond V and Ramona W Merle Trust totaling \$225,000. The first gift received in November 2020 was \$150,000, followed by a second disbursement of \$75,000 in March of 2021. There will be a final disbursement around the end of the this year as well. At this point, we do not know the amount of the final disbursement, as the estate still has substantial assets left to dissolve through probate. We will notify the membership as more details become available.

The LATOS Board voted unanimously that the gift be invested in a prudent portfolio which will yield income to offset the majority of LATOS' operating costs. After extensive research, LATOS treasurer Angie Hougen will be working with Merrill Lynch Wealth Management Officer Russell Reyes to meet those goals. The LATOS Board is very grateful that the Merle's estate planning will allow our organization to have long term financial stability and security.

NOMINATION AND ELECTION OF DIRECTORS

In accordance with the 2021 Bylaws, LATOS will accept nominees for the Board of Directors for a minimum period of thirty (30) days prior to the first meeting of the nominating committee. The 2021 period for nominations shall be October 1 - October 31, 2021. During this time, you may nominate yourself as a candidate for the Board of Directors and/or you may nominate another member of LATOS as a candidate with the written consent of your nominee. Three nominees will be elected to fill three vacant Board of Director seats for a term spanning from January 1, 2022-through December 31, 2024.

Per the 2021 LATOS Bylaws, Section 6.2(b), "Any person who has attained the age of eighteen years of age as of the date of election or appointment of directors, shall be eligible to serve as a director. No person shall be eligible to serve on the Board who is not a member in good standing of ATOS." 2021 LATOS Bylaws Section 6.3:

- (a) Elected Directors shall be elected in accordance with the provisions of this section. In the event that LATOS fails to comply with this section, then Elected Directors shall be elected at the annual meeting of members or at a special meeting of members.
- (b) Notice shall be given each year for a 30-day period in which nominations for positions of Elected Directors are open. Any member meeting the qualifications for serving on the Board established by Section 6.2 is eligible for nomination and may nominate himself or herself or be nominated by any other member. If a member nominates another member, written consent of the nominee must be received before the nominee's name can be placed on the ballot. Notice of any applicable nomination procedures shall be provided to members in conformity with written policy that was previously adopted by the Board prior to the notice provided in this Section 6.3(b).
- (c) The close of nominations shall be prior to the meeting of the Nominating Committee.
- (d) The Nominating Committee shall prepare a slate of candidates for the positions of Elected Director, which shall contain but not be limited to all nominations submitted by the members in accordance with this Section 6.3. The Nominating Committee shall report the slate of candidates for Elected Director to the Board within ten (30) days after the close of nominations. If, after the close of nominations, the number of nominees is not more than the number of directors to be elected, the Board then serving may without further action declare those nominated and qualified to have been duly elected.
- (e) If the number of nominees exceeds the number positions open, a written ballot and information about the candidates shall be sent to every member entitled to vote. The ballot shall name each candidate, arranged in alphabetical order according to last name. All ballots shall be returned to the place designated on or with the ballot and shall be postmarked prior to the deadline stated in the ballot. Ballots shall be counted the day following the last day for receiving ballots, provided that any ballots received thereafter shall also be counted provided that they were postmarked on or before the deadline provided herein.
- (f) The Board may authorize that the transmission of a ballot and any related material may be sent by electronic transmission by the corporation and that responses may be returned to the corporation by electronic transmission to the corporation.
- (g) Nominees who receive the highest number of votes up to the number of directors to be elected shall be elected. The results of the election shall be announced at the annual meeting and may be published to the membership in any reasonable manner established by the Board.
